- 1) Carefully cut out the slot in the roof (You may need to use a knife)
- 2) Score every red line
- 3) Score around the back and top of the vehicle and along the bonnet and windscreen.
- 4) Score along the ground line
- 5) Cut off all the solid blue areas and cut along all the blue lines
- 6) Pre fold along all the red lines to 90 degrees – make sure you include the folds above and below the windscreen, and above the grill and at ground level.
- 7) Bring **side A** round to the inside of the side with the address on
- 8) Fold in the flaps labelled 1st and 2nd
- 9) Bring in the flaps labelled 3rd and 4th
- 10) Tuck the bottom of the grill panel into the gap between 2nd and 3rd
- 11) Bring in the flaps at the back, tucking the door in last
- 12) If necessary carefully stick where required.
- 13) Start collecting for TWSRT
